#### **ORDINANCE NO. 383**

AN ORDINANCE OF THE CITY OF BANDERA, TEXAS, APPROVING A BUDGET AMENDMENT, PROVIDING FOR SEVERABILITY, REPEALING ALL ORDINANCES IN CONFLICT AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City of Bandera's current 2020-2021 Annual Budget was passed and approved on September 29, 2020; and

WHEREAS, the City has submitted a funding application under the Texas Water Development Board Flood Infrastructure Fund; and

WHEREAS, pursuant to the foregoing application the Texas Water Development Board has recommended the establishment of an operating balance within the City's Utility Fund equal to approximately thirty (30) days of operating expenditures; and

WHEREAS, staff recommends an amendment to the original budget to implement the recommendation, as such amendment serves a municipal purpose and has arisen since the original budget adoption, as authorized by Local Government Code Section 102.0101; and

WHEREAS, the City Council has determined that this budget amendment is necessary and proper, serves a municipal purpose and will help the City better protect the health, safety and welfare of the general public;

# NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BANDERA, TEXAS:

### Section 1. Amendment.

The City Council of the City of Bandera, Texas does hereby approve an amended budget for the City of Bandera General Fund and Utility Fund for the Fiscal Year beginning October 1, 2020 and ending September 30, 2021, as set forth in the attached Exhibit A.

# Section 2. Findings.

The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Ordinance for all purposes and are adopted as a part of the judgment and findings of the City Council.

## Section 3. Repealer.

All ordinances, or parts thereof, which are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters resolved herein.

# Section 4. Relation to Other Ordinances.

This Ordinance shall not be construed to require or allow any acts which are prohibited by any other ordinance.

#### Section 5. Effective Date.

This Ordinance shall become effective immediately from and after passage and any publication if required by governing law.

#### Section 6. Cumulative.

The provisions of this Ordinance shall be cumulative of all ordinances not repealed by this Ordinance and ordinances governing or regulating the same subject matter as that covered herein. This Ordinance shall not be construed to require or allow any act which is prohibited by any other ordinance.

### Section 7. Severability.

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this Ordinance be severable, and, if any phrase, clause, sentence, paragraph, or section of this Ordinance shall be declared invalid by judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of this Ordinance and the remainder of this Ordinance shall be enforced as written.

# Section 8. Proper Notice and Meeting.

It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.
