A RESOLUTION OF THE CITY OF BANDERA, TEXAS, APPROVING A PROJECT OF THE BANDERA ECONOMIC DEVELOPMENT CORPORATION, TO WIT: A REIMBURSEMENT OF \$40,000.00 TO THE CITY OF BANDERA, TEXAS, ONE HALF OF THE PRINCIPAL OF THE TWDB LOAN FOR DRINKING WATER IMRPROVEMENTS FOR 2021 FOUND BY THE BEDC'S BOARD OF DIRECTORS TO BE AN ELIGIBLE PROJECT UNDER THE ECONOMIC DEVELOPMENT CORPORATION ACT; PROVIDING FOR TWO SEPARATE READINGS; OPEN MEETING READING AND ADOPTION, AND AN EFFECTIVE DATE.

WHEREAS, the Bandera Economic Development Corporation ("BEDC") is a Type B Economic Development Corporation within a small municipality as defined by the Economic Development Corporation Act (the "Act"); and

WHEREAS, pursuant to the Act, the BEDC is authorized to spend sales tax funds for certain municipal projects, principally infrastructure, public parks, and other community and/or recreation purposes as defined within Section 505.152; and

WHEREAS, in the election creating the BEDC, the voters specifically authorized the proceeds of the sales and use tax levied to be used for all purposes authorized by the Act, including but not limited to use exclusively for water, sewer, drainage and street improvements and the maintenance and operating costs associated with such project as defined in Sections 505.154 and 505.158; and,

WHEREAS, the Board of Directors of the BEDC (the "Board") has agreed to provide funding for a project the Board finds to be an eligible project under the Act by reimbursing the City for one half of the principal of the TWDB Loan, drinking water improvements, for 2021 in the amount of Forty Thousand Dollars and no cents (\$40,000.00) ("the Project"); and

WHEREAS, the City Council also finds, that the project is an eligible project under the Act and is budgeted for within the Fiscal Year 2020 – 2021 Budget, as adopted by the Board and approved by City Council; and

WHEREAS, the action authorized by this Resolution is in furtherance of the public interest, for the good government, peace, order, trade and commerce of the City and necessary and proper for carrying out of the authority granted by law to the City and the BEDC.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BANDERA, TEXAS, THAT:
